## ERIC C. MACFARLANE, DEPUTY COMMISSIONER, INFRASTRUCTURE DIVISION, NYC DEPT OF DESIGN AND CONSTRUCTION TO SPEAK MARCH 6, 2013

ric C. Macfarlane serves as the **Deputy** Commissioner of the Infrastructure Division of the NYC Department of Design and Construction. Since May, 2006, he has been responsible for managing an annual operating budget of \$32 million. He is also responsible for the management of design and construction of the consolidated roadway, sewer and water main capital programs for the City of New York. The Division has 490 employees, the majority of whom are engineers, project managers, and analysts. The division has a 5 years capital plan portfolio of more than 400 design and construction projects City wide valued at approximately \$3.7 billion. The Infrastructure Division also procures the services of a large number of consultants for both design and construction management who provide supplementary assistance in the delivery of the City's capital construction annual commitment plan totaling \$600 million. Additional nearly responsibilities include extensive interaction with other agencies, community boards, and elected officials.


Prior to his current position, Mr. Macfarlane served as First Assistant Commissioner of the Infrastructure Division, Engineering Audit Officer, and Director of Program Management for Brooklyn and Manhattan, Infrastructure Division.

Prior to joining the NYC Dept of Design and Construction, Mr. Macfarlane worked in previous positions with the NYC DEP, Con Edison, Manuel Elken Co. P.C Consulting Engineers, and Greeley and Hansen Consulting Engineers.

Mr. Macfarlane holds a Master of Science, Civil Engineering, 1981 from Polytechnic Institute of New York. (NYU-POLY) and a Bachelor of Civil Engineering, 1975 from the City College of New York (CCNY).
